





# Q3 Should any medical marijuana facility be allowed in Chassell Township?












## Q9 Should Chassell Township restrict the number of medical marijuana facilities allowed within the Township?






## Q10 Should Chassell Township restrict the location of medical marijuana facilities from residential areas, schools and parks?



### Q11 Based on the answer in #9 what should the minimum distance be.




