  - iii. Keith and Ericka met with Sinclair Recreation/GameTime to discuss playground equipment. Rich with Sinclair to provide renderings and examples to include with the grant application.
  - iv. mParks is another grant opportunity that may be applied.
  - v. Match will also come from the Recreation Millage
- b. Snowmobile Trail Update
  - i. Survey sent to property owners

- d. Fitness Trail Issues
  - i. A lot of traffic on the trail this year
  - ii. Difficulties-people are not following the rules (dogs, going the wrong way on ski trails, walking/snowshoeing on ski tracks)
  - iii. Working on basic signage with symbols instead to shown directions and where dogs are allowed
  - iv. Colleen who helped with the video for the fitness trail, is finalizing

the videos and directions. She's writing a grant proposal to get signage for instructions that can be posted at each station.

  - ii. Potential to pursue a grant through the MEDC
- f. Recreation Millage Budget
  - i. Rec Millage brought in \$31,000 in the first year
  - ii. Fitness trail, Canoe Kayak Launch, Dog Park all funded and had grant match money to maximize taxpayer dollars.
  - iii. Plan to compile a summary that can be posted odn the website summarizing how much millage money was spent, grant money and projects completed. Brian to ask Lynn to do this.
- g. Zoning Concern 41868 South Hancock Street
  - i. Zoning administrator is looking into
- h. Disc golf addition
  - Working with Chassell schools to research adding a disc golf course behind the school on the Township property behind school property. Approximate costs \$5,500-\$2,300 for 9 baskets, site work not included.
  - ii. Grants available for 50/50 match
  - iii. Has connections with those that designed local courses at Lake Linden and Calumet.
  - iv. Group agrees that it's a good opportunity for the Township. Low cost and low maintenance. Fun, active committee. Trevor to continue discussing with the school.
